We want to buy some basic equipment to provide history themed walking tours in various locations within Carrick. Two walks have already been written for the coastal communities of Girvan and Dunure with more planned. We are also looking for funding to create a pilot project of manufacturing a themed 'Top Trumps' style card game that can be used by families to learn more about the area they live in. The walks will be tailored by theme and for all ages. They will also encourage good mental wellbeing through exercise. We will also work with local young people to encourage them to get outside and learn more about their area.

The whole of Carrick will benefit but mainly those communities with a lot of heritage and in particular, Girvan, Dunure and Maybole initially.
